**President's Report**

- *Archives / Historical Department* – Frank Brehm has resigned as Department Head for personal and procedural reasons effective October 1. President McClure has had two long conversations with Mike Mucklin concerning the historical and archives situation. Mike Mucklin is now (temporarily) the head of the Archives Department. Dave Pires continues as the Headlight Editor. Kirk Baer is now the Archives

Custodian (keys and access). Eugene Vicknair will continue to handle Conventions. The Archives Department will follow three rules: for right now, no removal of archives from property (except for specific use for Headlight / publications), monthly / semi-monthly reporting, and no more uncontrolled access to the archives. Revised procedures are being looked at. Visits to archives will be handled by Kirk Baer and Mike Mucklin is working on rules and procedures. Mike Mucklin has requested that at this time, all archives materials should be returned to Kirk Baer as soon as possible. Mike Mucklin and Dave Pires are working on a scanning and organization plan, including implementing use of PastPerfect software. Current boxcar storage on museum property need to be sorted. Cotton Belt boxcar, Simplot reefer, MoP conference baggage car and mechanical PFE reefer all have archives stored in them. Non-archives items from Simplot car will be removed as soon as possible so that materials in PFE can be moved into Simplot car. Suggestion to donate all Milwaukee Road signals to Milwaukee Road organizations. Mike Mucklin is working on changes to existing archives policies and procedures. He will also be working with Dale Sanders on issues of his access to Meeker collection. Goal is to address all concerns that have been brought forward by members and provide a path forward.

- *WP SW1500 1503* – Repaired and working well. Will start getting prepped for painting over winter.
- *MILW U25B 5057* – Went out the gate on October 15. All repairs have been made. Wayne Monger did a lot of work, along with Dave Elems, Jeff Saunders, Kirk Baer, Steve Habeck, Rod McClure and Bart Hansen. FRRS members have done a lot of work to make this engine movable.
- *Hines, OR* – Has been discussing Baldwin AS-616 sale with Hines. They have started a 501c(3) to acquire and they are talking to the Union Pacific about movement.
- *Beet Gons* – Nothing yet from Pacific Locomotive Association about beet gons.
- *Portola City Manager* – Had a good meeting with new City Manager. Went very well. He recognizes the museum as being a “diamond” for Plumas County tourism. Wants to put Norm Holmes’s Plymouth engine (Feather River and Western 1) at the William’s House. Likes the idea of the Old Town Portola track extension. Wants to do a lot of economic development in Portola.
- *Military Flatcar* – Has been moved off property and turned over to owner John Salisbury.
- *WP Derrick MW37* – Broke but has been repaired
- *Shop Clean-up* – Lots of clean-up going on and shop being reorganized.
- *Batteries* – Reno recycler will only take lead, we would have to dismantle. Looking at bringing dead batteries to Sims in Bay Area.
- *Railway Passenger Car Alliance* – Convention in Reno in January. Will be coming to museum for visit January 25.
