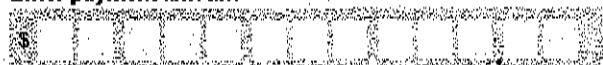

Financial Summary, September Meeting, 2012

James H. Mason, Volunteer/Life-Member

Cash Flow: During August 1-August 31, 2012, we had income of \$26,862. During that same period of time, we spent \$13,763.

Cash in Bank of America Account: On August 31, 2012 we had \$51,372 available for paying bills. *(Note: This number changes daily with business activity.)*

New and Renewal Memberships: We are \$770 behind last year at this time.

Credit Card Balance, July 15, 2012: \$17,715. Finance charge of \$163.

Credit Card Balance, August 16, 2012: \$19,949.

Cash performance, Year-to-Date: So far this year we have booked income of \$155,703. Our expenses have been \$117,012. On August 31, 2012, our current net profit is **\$38,691**. This compares with last year at this time, when we had a deficit of **-\$29,775**.

COMMENTARY

This is my first Summary to the Board as a Volunteer/Life-Member.

1. **Credit Card:** At the August Board Meeting, Tom Carter proposed bringing the outstanding balance down. After discussion, the Board directed that all current monthly charges be paid in full each month, the "minimum payment due" be paid, and an additional \$500 be paid each month. This has resulted in a new Current Liability on the Balance Sheet, (#26000), of \$16,715. The Board will revisit and review this procedure in 3 months.
2. **Cash Performance:** Our income is down over \$16,000 from last year at this point. However, our expenses are down nearly \$85,000 from last year at this time. This is a very good trend to leave us with a profit at the end of the year. The regular operating season is winding down. Now, it's up to the Board of Directors to focus on and engage in strong fund raising efforts to get us through the first half of 2013, until the new season kicks in, and provide the necessary cash flow for continued operation of the FRRS.
