

Financial Summary

FRRS Board of Directors Meeting

Available Cash: As of February 28, 2015, the Bank of America general operating account contains \$23,786.95 and the Bank of America internet account contains \$12,626.85 for a total available balance of \$36,413.80. This amount reflects the \$15,000.00 down payment on the new steel building, \$9,901.28 insurance expense and \$6,029.04 in expenses for the WP 165 along with normal utilities and a minimal amount of inventory for the Gift Shop. We need to be very careful with expenses right now as we do not have much revenue coming in to balance it out. We will have additional insurance, Gift Shop merchandise (which I should be able to get 60 day terms for most of what we need to purchase), convention, and normal operating expenses which will need to covered before revenue starts coming in. As a side note: We have our first RAL booked for April 19th and at least two tours in the first couple of days of May.

Credit Card Balance: The current credit card statement was unavailable at the time of the writing of this report, however, the current outstanding balance, not including current charges, should be around \$2,000.00. While I previously suggested that we review complete payoff of the outstanding balance around this time, I recommend we continue with the current plan of \$500.00 per month plus current charges and interest until paid in full.

Memberships: Membership dues are up 14.36% over this time last year (New memberships up 603.69% - \$920.00 vs. \$130.00, Renewals down by 14.69%- \$2,265.00 vs. \$2,655.00). Hopefully, we can recruit a few new members at the convention and we always have a few renewing members who do so at Winterail.

Profit & Loss, year to date: We have booked revenue of \$15,780.41 and have expended \$44,691.76 (compared to \$7,982.14 and \$36,292.82 respectively this time last year). The result is net income of \$-28,911.35 compared to \$-28,310.68 last year at this time. The Board needs to look seriously at advertising in April to draw more visitors throughout the season. The more bodies we get in the door, the more money we are likely to bring in and the more projects we will be able to complete without finding ourselves in a difficult position come fall and the start of our dry season.
