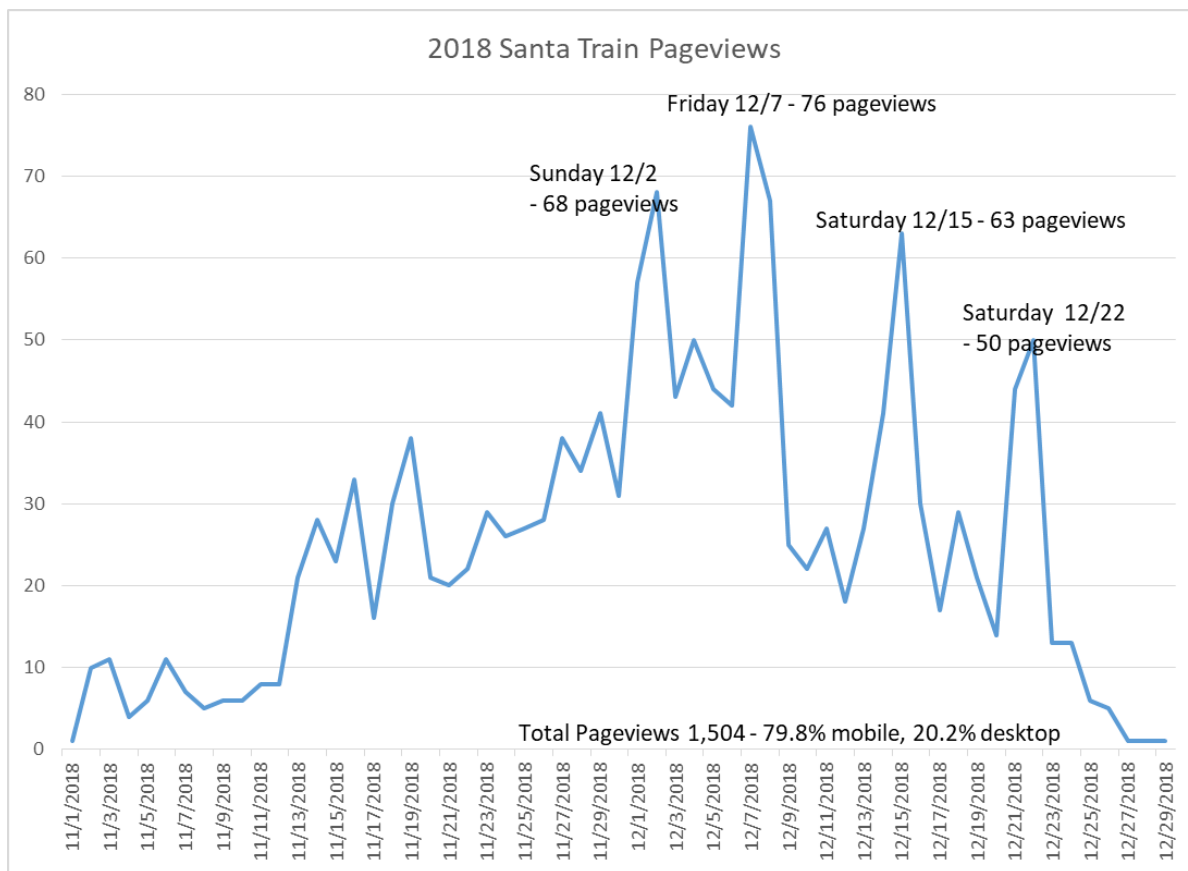
## Website Videos

As previously reported, YouTube changed the behavior of website embedded videos. One of the side effects of this change is when the video ends, links to related videos are displayed. I was not happy with this behavior because the related videos could be unrelated to the FRRS/WPRM. After doing some research, I learned how to make the “related videos” at least come from the same YouTube channel as the initial video. To make the related videos really related to the FRRS/WPRM, I moved most of the existing videos that were not already on our channel from the previous channels to the FRRS WPRM YouTube channel I created in July 2017. Some of the videos were on my channel, some were on Kenneth Finnegan’s and some were on Tom Carter’s. A few videos that go to other channels (e.g. the Video from Steve Cavanaugh's Layout video in the Historical/Archive department’s modeling page goes to the Model Railroad Hobbyist magazine channel) I left unchanged since we do not have rights to host that material.

## Santa Trains

In December, I kept the website up-to-date with the information I had for the Santa Trains. It seems there was some confusion for the public that they needed advanced tickets or reservations and that we were sold out. Working with Eugene Vicknair and Big Fish, we added some words and I changed the presentation on the web pages to clarify how the WPRM Santa Trains work.

I received some photos from Michael Clawson and Greg Elems and created a [Santa Trains 2018](#) gallery.



In 2018 we had 1,504 pageviews of the Santa Trains information, in 2017 it was 918, in 2016 it was 732.
