BARTD cars ride Western Pacific

The first of several maintenance of way hopper cars arrived at BARTD's maintenance shop in Hayward during January after riding WP on standard-gauge trucks. Since BARTD's track gauge is 6 inches wider an extra set of wide-gauge trucks rode inside the hopper car body, a unique method to effect easy changeover at Hayward.

Three old engines

It might be a different story were it not for Sales Representative Joseph A. Malaspina's invitational tour of the Levin Metals Corp. yard in Stockton. Looking at what might have been 180 tons of heavy-gauge scrap steel, Joe's sharp eye caught the reflection from what turned out to be the top of an engine stack. Confirmed by Langdon George, Levin Metals Corp. manager, Joe was told that the engines were part of the inventory purchased by Levin Metals Corp. four years ago from a previous owner who bought the engines in 1947.

In 1969, Levin Metals Corp. received one of hundreds of letters sent out to scrap dealers by Jay R. Edwards, a railroad buff president of his own railroad museum in Heber City, Utah, seeking abandoned locomotives. Levin donated the three engines to Edwards' museum as a public service but it was not until last December that he could take possession.

operating condition and lease them to the Wasatch Mountain Railroad, a Heber City tourist steam run known as the Heber Creeper.

To arrange the move by WP from Stockton to Utah, Joe got help from Jack Hyland, retired assistant freight pricing manager, in establishing a special rate and the engines were enroute.

The January award went to Kenneth W. Craig, conductor at Stockton, whose WP employment began on June 12, 1941. Ken has been formally commended three times for alertness and safety—on March 8, 1960 for detecting a broken rail at Milepost 102; on September 28, 1958 for extinguishing a fire on Bridge 190.84; and on February 15, 1954 for handling of a derailment at Trevarno. Ken has never had an injury, and his discipline record is outstanding.

Railroad Retirement Program being studied

Changes in the railroad retirement program—designed to provide “adequate levels of benefits on an actuarially sound basis”—will be recommended to Congress this year. The study was authorized by Congress in August 1970 under an act which also increased railroad retirement benefits by 15 percent. The study group includes representatives of management, labor, and the general public.

“Establishment of this special Pension Study Commission resulted from a recognition by Congress that there is need for an evaluation of the railroad retirement system to assure that it is financially sound and able to meet future requirements under conditions which have changed considerably in recent years and will probably change drastically in the future,” said John P. Hiltz, Jr., chairman of the National Railway Labor Conference and a member of the Commission.

“The Commission will file its report with Congress on or before June 30 of this year, and Congress, after studying the Commission’s recommendations, will make the final decisions about what’s to be done,” said Hiltz.

Retirement Program . . .

In the act creating it, Congress suggested a number of factors for the Commission to consider in arriving at any changes it might recommend in the retirement system, such as:

- The need for providing benefit increases . . . in line with past and future increases provided for in the Social Security Act.

- The need for revising benefits to meet increases in the cost of living.

- The adequacy of benefit levels.

- Changes necessary to continue the 15 percent increase in the level of benefits provided for by Congress last year.

- The possibility of changes in the financing system used to pay railroad retirement benefits, including adjustment of the tax rate and tax base, the use of general revenue financing and revision of the investment policy of the railroad retirement fund.

- And the relationship between Social Security and railroad retirement

in the areas of benefits, tax rates and tax base, and the desirability and feasibility of merging the systems.

Railway pension payments now average \$229.41 a month for retired workers, with \$406 a month as the maximum. In addition, a pensioner's wife averages \$102.32 monthly pension, with \$152 as the maximum. A pensioner's widow, with three dependent children, collects a family pension of \$444 a month.

Disability pensions for retirees average \$220 a month, with a \$406 maximum. Widows average \$139.06, with a \$199 maximum, and disabled widows average \$157.91, plus \$109.22 for each child.

The railroad also provides a supplemental pension ranging from \$45 to \$70 a month for workers who have retired since June 1966 if they retired directly from railroad service after at least 25 years of employment. A 25-year man gets an extra \$45 and a 30-year man gets an extra \$70.

Last year for the first time in its history, the Railroad Retirement Fund's payout exceeded income. The fund paid \$1.942 billion to 980,000 beneficiaries while taking in \$1.850 billion in payments from 650,000 active employees and their employers, plus interest on \$4.718 billion reserves invested in Government securities.

Starting January 1, 1972 the railroads and each employee will pay into the fund an amount equal to 9.95 per cent of the first \$750 a month of a worker's earnings, or \$74.63 from the carrier and the same from the employee. Next January 1 payments will increase to 10.40 per cent of the first \$750 monthly earnings.
